As your former investment company have unfortunately fallen into receivership, they can no longer accept any funds on your behalf, therefore the responsibility for the release of capital now belongs to the legal sole beneficiary held on file.

If your TRN number has expired or you can no longer locate the relevant documentation stating your 16-digit trade reference license agreement number, we can apply for a temporary license or reapply for a renewal to enable you to release your capital. If you opt for the temporary license the duration will last for 14 working days, before expiry. A permanent license will last for 12 calendar months, before expiry. Either license you opt for will be fully reimbursed back to you on the same day as your scheduled investment proceeds.
